Dear Esteemed Members,

It is my privilege and pleasure to extend to you all a warm and hearty welcome to the 15th Annual General Body (AGM) meeting of FRNV. This year is significant as our organization has completed 15 glorious years since 9 th June 2008.

It is with some satisfaction with which I say that our organization is gaining strength with more members. Chennai, Hisar and Karnataka Chapters have come up. Chennai Chapter has people with shared values. More such chapters are planned.

The bi-monthly print journal (Value Insight) has started from June 2022 and successfully completed one year. About 250 copies are getting printed on each issue and circulated to Life Members, Regional Chapters and educational institutions. Annual subscription is Rs.1,000/- only and I request all to subscribe to the Journal and spread the journal in your areas.

During the year, your organization has created new membership Associate Membership for academicians (principals/professors/teachers/students), to whom the membership fee has been reduced 50% in annual membership and 25% in life membership.

During the year, 2 schools workshops (one at Balvantray Mehta Vidya Bhawan, Greater Kailash and M L Khanna DAV Public School, Dwarka, both at New Delhi), one youth training workshop at Rishidwar, Uttrakhand and one corporate workshop were organized. More than 100 teachers participated. Recently in July 2023, ½ day virtual workshop on Universal Human Values was organized jointly with IIT-Delhi professionals. Another school workshop in August 2023 was organized at Kamal Model Sr. Secondary School, Mohan Garden where about 100 teachers participated. With the active involvement of Regional Chapters, more such workshops could be conducted.

I would now recommend various resolutions, audited reports and General Secretary's annual report that will be tabled in the AGM for your consideration and acceptance.

FRNV Vision

FRNV will strive to restore our time-tested National and cultural values, so that people, individually as well as collectively, find an abiding inner persuasion to be truthful, ethical, patriotic, and committed to wholesome development of the Nation.

Aims & Objectives

Dedicated towards creating more ethical value based leadership driven by conviction so that leadership with integrity creates most appropriate conditions in democracy for all around National development.

- I. Aims at creating ethical leadership in the areas of business, administration, police, politics and value based education.
- II. Hopes to stimulate awareness among all members of the society, about the importance of the Duties of the Indian citizens, through its actions.
- III. Restore the National and Cultural Values of the country, so as to enrich and empower the Administration as well as its citizens.
- IV. To work towards the strengthening of ethical standards in the Executive, Judiciary as well as people's bodies and representatives, and all other agencies that interact with citizens, and endeavor to inculcate standards, so as to enhance their ability to understand and serve the needs of society in a way that upholds and fosters the greater good.

Our National Values

The solution to the value crisis lies in the inspiration provided by the three stable pillars on which independent India has vouched to rest firmly:

- 1. National Motto; 'Satyameva Jayate'; signifying that 'truth shall prevail', which we chose for ourselves, in the wake of independence.
- **2.** *National Flag;* that proclaims ceaselessly the message of inner sacrifice, inmost purity, preservation of natural abundance, and vitality of the Earth.
- **3.** Fundamental Duties in the Constitution; enjoining each one of us to value and uphold the composite culture of our country, and to be inspired by the great ideals that led our national struggle for independence. Together, these make an exquisite triangle encompassing all our National values, and FRNV draws its inspiration from this ocean of strength.

Our National Values consist of discipline, restraint, and the ideal to stimulate the consciousness of all, to achieve:

- Eradication of inner constrictions born out of selfishness and greed;
- $\bullet \textit{Imbuement of a warm fondness for society and concern for the collective good; and}$
- Building of sufficient inner strength and character, in the individual, family and society as a whole.

Our Focus Areas

Towards creating a Value-based Society, FRNV focuses on the following areas:

1. Values-Based Education:

The main focus of this project is to implement FRNV's Values-based education methodology across schools in our country. FRNV's mission is to become known as an 'Opinion Leader' in the area of Values-based education in the country.

2. Electoral and Administrative Reforms (including Judicial Reforms):

FRNV will focus on achieving the following:

- Prevention of people with criminal background from contesting elections.
- Prevention of money and muscle power in conduct of elections.
- Legislative backing to implement code of conduct during elections.
- Speedy disposal of poll petitions and criminal cases against poll candidates.
- Ensure accountability of elected representatives to the electorate.
- Improve transparency and effectiveness in public administration.
- Ensure greater governance with less government; and Speedy disposal of pending cases in courts.

3. Police Reforms:

- FRNV will focus on achieving the following: -
- Implementation of recommendations made by the Supreme Court.
- Prompt registration of First Information Reports and Investigation.
- Proper follow up of prosecution cases in courts.
- Making police people friendly, and Setting up of effective Police Complaints Authority (PCA) and prompt deterrent action against offenders.

4. Sanitation and Hygiene:

FRNV advocates on waste segregation, solid-waste management and educating citizens about civic sense.

5. Corporate Engagements for Ethics & Governance:

At the Foundation for Restoration of National Values, we believe that corporate integrity is important to attain sustainable development. We seek to stimulate the inner consciousness of corporate leaders and strive to maintain a high level of transparency within the organizations.

Our Regional Chapters

FRNV does not restrict itself within the region of Delhi and aims at expanding its motives to all parts of the country. The efficient functioning of the regional chapters will ensure effective implementation of police reforms in the different states as per Supreme Court directives, implementation of value-based education in the different tiers of education across all states of the country and to implement electoral and administrative reforms across the nation in an attempt to prevent value erosion and eradicate corruption.

Foundation for Restoration of National Values has five Regional Chapters:

1. Two Kerala Chapters-Trivandrum & Kochi

Trivandrum Chapter is headed by Dr M. Ayyappan. They are doing work on Sanitation/Hygiene and training corporate houses on conducting business with ethics.

Kochi Chapter is headed by Dr. Devika Menon under direct guidance of Life President Dr. E Sreedharan. They are doing work on value education for students and disaster management.

2. Karnataka Chapter-Bangalore

Karnataka Chapter is headed by Sri S L Gangadharappa. The chapter was launched on August 13, 2016, at Bengaluru. This chapter has been working in the following areas: Values-based Education, Corporate Integrity and Police Reforms.

3. Tamil Nadu Chapter - Chennai

Tamil Nadu (Chennai) Chapter is headed by Sri Mahalingam Balasubramaniam. Sri Balasubramaniam took over as Convener of the Chapter on 2nd July 2022 in Chennai.

The chapter has taken up the Teachers' Manual and translated in Tamil, Malayalam and Kannada languages. The local language versions are distributed for Aacharyas in Schools for teaching the students. The chapter has been working on Values-based Education, etc.

4. Haryana Chapter – Hisar

Haryana (Hisar) Chapter is headed by Sri Jagdeep Bhargava. Shri Bhargava took over as Convener of the Chapter on 2nd July 2022 in Hisar. The chapter has been working on Values-based Education, etc.

Organizational Structure

Swami Bhoomananda Tirtha, the managing trustee of Narayanashrama Tapovanam (NAT), P.O. Paralam, Thrissur District, Kerala, and also the Founder of the centre for Inner Resources Development in Vasundhara, Ghaziabad, U.P. is the inspiration and guiding force for the FRNV.

There is an Advisory Board consisting of very eminent personalities to guide the Governing Body in managing the activities of FRNV. The Governing Body looks after and manages the day to day affairs of the society. It will consist of a minimum of five and maximum of fifteen members including the office bearers for the purpose of "overall supervision over the activities of the Foundation".

SECTION II

FRNV Activities 2022 - 2023

The year 2022-2023 was better when compared with two previous pandemic affected years.

• The 14th Annual General Meeting of FRNV was held on 4th September 2022 in Hybrid mode (physical & virtual) in the Registered Office of FRNV.

In spite of constraints, review of FRNV performance reveals that with regular weekly participation by Governing Body members and involvement of regional chapters, FRNV had been able to achieve the following:

- Regular issue of e-journal Value Insight by arranging voluntary input/original articles relating to values, from accomplished persons/ professionals of the Society, thereby creating a pool of 20 or more authors with mindset on principles of FRNV with minimal expenditure.
- With approval of RNI and observing/complying their guidelines, successfully arranged approval of the Print version of Journal in March 2022. This has become a bench mark.
- Series of discussions and meetings with Knimbus to use their platform to expand readership on a regular basis which is now taking final shape.
- Inspiring and involving existing 5 Chapters in regular monthly meetings.
- Deliberations considering ways and means for fixing seminars for Corporates, forming a team, to work out a way forward at the earliest and also take up value education in a few schools.

Strengthening the Organization

The last two years of Covid-19 pandemic had affected the functioning of every organization. Physical meetings gave way to online interactions. One of the priority area identified is to strengthen the organization. More regional centres with active members are required. Discussions have taken place and new chapters in Hisar and Chennai were set up.

Value-based Education

The recommendations of FRNV on Value-Based Education have generally been accepted by the Government of India and have been included in the New Education Policy (NEP) 2020. Most of the State Governments had taken steps to implement the NEP 2020.

The Government had constituted under the chairmanship of Dr. Kasturi Rangan to design curricula and syllabus as per NEP 2020.

Corporate Integrity:

At the Foundation for Restoration of National Values, we believe that corporate integrity is important to attain sustainable development. We seek to stimulate the inner consciousness of corporate leaders and want to underpin the point that there is enough for everyone's needs, but not for their greed.

Our esteemed corporate members include AFCONS Infrastructure Ltd, GMR Group, Oil and Natural Gas Corporation Ltd., Lucknow Metro Rail Corporation Ltd., Delhi Metro Rail Corporation Ltd., Mumbai Metro Rail Corporation Ltd., Tata Sons Ltd., NTPC Ltd., RVNL, COAL India, Cochin Shipyard Limited, RBG Enterprises Pvt. Ltd., and Krishna Sales Corporation, Kochi.

Important Events and Meetings

I. The Governing Body re-iterated the following for FRNV:-

a) National Values

b) Constitutional Values

FRNV promotes National Eternal & contemporary Values which are already enshrined in the National Flag, the National Moto, 'Satyamev Jayate' (Truth Alone Triumphs) and the Fundamental Duties as enshrined in the Constitution. Some of these values are eternal: Truth, Non-violence, Righteous conduct and Preservation of natural abundance and vitality of the earth. Other Values which we promote are Contemporary Values. These are: Justice, Liberty, Equality, Fraternity, Sensitivity, Teamwork, Discipline, Responsibility and Respect for self as well as others.

Out of the above, Equality (opportunity to everyone), Compassion (care and service to others), Non-violence, Integrity (innermost purity, honesty), and Discipline/respect for rule of law shall be the focus values.

c) Universal Values

Simultaneously, following Universal Values shall be adhered by FRNV and its members:-

- Truthfulness
- Righteousness
- Non-violence
- Compassion
- Bhakti-devotion to God, Desh Bhakti, Mother, Father, Guru and God

Re-organization to Advisory Board

Based on our request, Shri O P Rawat, IAS (Retd.) and former Chief Election Commissioner has kindly agreed to be Advisor in FRNV Advisory Board. Retd. Justice Anil R Dave has been requested to be part of FRNV Advisory Board, confirmation is awaited. Justice Mahesh Grover of Chandigarh High Court, former CIC and also former Chief of Navy Admiral R K Dhowan are also being approached to be part of FRNV Advisory Board.

With these new members, FRNV Advisory Board will be strengthened. Action points including Electoral Reforms, etc., are planned to be taken up. It was felt that the Advisory Board has to be more participative and meet at least once in six months.

a) School Workshop on Values Based Education. Two workshops held in September 2022 (Balvantray Mehta Vidya Bhawan, Greater Kailash, New Delhi) and December 2022 (M.L. Khanna DAV Public School, Dwarka, New Delhi). A total of about 80 teachers participated in these two Workshops. Smt. Sharda Kumari, retd. Deputy Director, SCERT is conducting the Workshops. She has also been requested to be Head, VBE Task Force, FRNV. More workshops are planned after the examinations.

b) Corporate Workshop

c) Youth Training

one Training Camp was organized from 21-25 December 2022 in Aurovalley Ashram, Rishidwar, Uttrakhand. The camp was jointly organized by Servants of the Peoples Society and FRNV. About 40 participants attended, mostly from Gujarat, Odisha, Uttar Pradesh, Uttrakhand and Delhi.






$\frac{1}{2}$ Day Virtual Workshop on Universal Human Values jointly with IIT Delhi professionals - 23rd july 2023

Half a day virtual workshop was organized on Universal Human Values. The workshop was jointly organized by IIT-Delhi professionals and FRNV. The program got good response and more than 200 guests registered and about 130 participated in the workshop.

More such workshops are planned to be organized including 3 days and 5 days physical workshop to interested members.



Budget - Income & Expenditure

- In February 2022, Life President Dr. E Sreedharan suggested to build a corpus of Rs.5 crores for FRNV.
- For FY 2022-2023, an income of Rs.16.91 lakhs raised and while expenditure was Rs.18.53 lakhs.
- Rs.20 lakhs had been projected to be raised during the financial year 2022-2023 to meet the expenditure without disturbing reserves. An amount of approx. Rs.15 lakhs had been raised.
- Against a projected expenditure of Rs.40 lakhs, an amount of about Rs.19 lakhs had been incurred.

Strengthening Organization

- Emphasis on strengthening Regional Chapters and monthly meetings with Regional Chapters Conveners held.
- Regional Chapters in Chennai, Hisar and Karnataka set up. Shri M Balasubramaniam, Shri Jagdeep Bhargava and Shri S L Gangadharappa are Conveners of Chennai, Hisar and Karnataka Chapters respectively.
- Due to professional commitments, Shri Vishwanathan is unable to continue Convener of Karnataka Chapter.
- In Odisha, Shri Arun Kumar Rath, IAS (Retd.) has agreed to be Convener of the Regional Chapter.
- More Regional Chapters in Maharashtra, Gujarat, Uttar Pradesh and other States are planned.
- Bi-monthly Print Journal of FRNV Value Insight commenced from June 2022.

Future Planning

• Discussions are on with IIT-Delhi professionals who are spreading Universal Human Values (UHV) in higher educational institutions. UHV team have experience of more than 20 years and with AICTE approval, their UHV courses are taught in about 50 colleges/technical institutions. They are seeking FRNV assistance in making the UHV courses available to all educational institutions through the Government. They also would like to train FRNV volunteers/team so that the values are spread. FRNV also contemplating corporate workshop with the support of UHV team.

Program of UHV is enclosed at Annexure.


- Collaboration with Ekal Vidyalaya is under discussions. Two rounds of initial discussions were held with Ekal and also field visit to their School in Mathura in August 2022. Teachers Manuals were shared with them. Their feedback is awaited.
- Discussions were held with Knimbus (a digital platform) for disseminating FRNV values to larger audience specially student community. Data on FRNV newsletters, journals, annual report, etc., have been stored in Knimbus platform. Colleges in Kerala are being approached to allow their students to access FRNV updates. Kochi Chapter Convener Ms. Devika Menon is coordinating with the Colleges. Response is not encouraging.
- With the wide reach of SOPS, their members are being encouraged to be part of FRNV also to strengthen FRNV.

FRNV Administration

- (I) Website is made robust with online membership portal, online payment mechanism including easy QR code availability, made functional.
- (ii) 14th Annual General Meeting with FRNV Members held in September 2022.
- (iii) Governing Body meetings were held every quarter.
- (iv) Regional Chapters Review meetings were held regularly.
- (v) Weekly Review Meetings were held to plan and implement FRNV activities.

Way Forward

- (A) School Workshop organize School Workshop for Values Based Education, starting from Delhi and in FRNV Regional Chapters.
- (B) Electoral Reforms prioritize electoral reforms in consultation with FRNV Advisory Board and spread the message across the country.
- (C) Electoral Reforms entry of criminals and election spending by political parties are also on the agenda for guidance by the Advisory Board.
- (D) National Link Language initiate steps for a National Link language

40+ universities in 10 states of India were conducting the UHV foundation course as a core part of their academic curriculum. From 2022 UGC has also started exploring this approach. It is being intensively tested at over 300 CM Rise Schools in Madhya Pradesh through the aegis of Rajya Anand Sansthan, Government of Madhya Pradesh.

Publication of Journal titled "Value Insight" (E-Journal)

An important achievement of FRNV in the recent times has been publication of a bimonthly E-magazine through which we are able to convey Ethics, Values and Principles of our sacred country to a large section of our society. The organization in June 2020 decided to launch this bi-monthly journal "Value Insight" and got the name registered with the Registrar of Newspapers of India. For this purpose, a group of Members from the Governing Body took the responsibility of the Editorial Board and with continued follow-up, FRNV could get the Title Name registered within a short time and approval received on 28th December 2020. The e-journal was launched in January 2021.

Publication of Journal titled "Value Insight" (Print Journal)

An important development during the year was authentication of the journal by the DCP/Licensing office on 8th March 2022. With this, FRNV could print and circulate its journal "Value Insight". The first printed journal was published in June 2022. All necessary documentation along with a copy of the printed journal had been submitted to the office of RNI for getting the registration certificate for the print journal.

The Editorial Board consists of Shri Satish Kumar, Editor and Shri Ashwani Kumar, Shri Prem Arora, Shri Sunil Kumar Singh, Shri Ravi Prakash Mehrotra and Smt. Sudhamahi Regunathan as Members of the Editorial Board. From 15th September 2022, Smt. Shriti Nath has consented and joined FRNV Editorial Board as Consulting Editor. Her contribution includes collection and editing the articles for the entire Journal.


