

FRNV Vision

FRNV will strive to restore our time-tested National and cultural values, so that people, individually as well as collectively, find an abiding inner persuasion to be truthful, ethical, patriotic, and committed to wholesome development of the Nation.

Our Aims & Objectives

Dedicated towards creating more ethical value based leadership driven by conviction so that leadership with integrity creates most appropriate conditions in democracy for all around National development.

- I. Aims at creating ethical leadership in the areas of business, administration, police, politics and value based education.
- II. Hopes to stimulate awareness among all members of the society, about the importance of the Duties of the Indian citizens, through its actions.
- III. Restore the National and Cultural Values of the country, so as to enrich and empower the Administration as well as its citizens.
- IV. To institute and propagate, ethical knowledge and disciplines, especially Value-based insights, as applicable to all sections of people without any distinction of gender, caste, creed or religion, with a view to promote and preserve individual, social and universal well-being, development, collective wisdom and peace.
- V. To imbue on the basis of our common heritage, moral and ethical values and principles, that foster civic sense, concern for others and the environment, in members of all sections of the society without

- VI. To work towards the strengthening of ethical standards in the Executive, Judiciary as well as people's bodies and representatives, and all other agencies that interfere with citizens, and endeavor to inculcate standards, so as to enhance their ability to understand and serve the needs of society in a way that upholds and fosters the greater good.

Our National Values

The solution to the value crisis lies in the inspiration provided by the three stable pillars on which independent India has vouched to rest firmly:

- I. National Motto; 'Satyam-eva-Jayate';** signifying that 'truth shall prevail', which we chose for ourselves, in the wake of independence.
- II. National Flag;** that proclaims ceaselessly the message of inner sacrifice, inmost purity, preservation of natural abundance, and vitality of the Earth.
- III. Fundamental Duties in the Constitution;** enjoining each one of us to value and uphold the composite culture of our country, and to be inspired by the great ideals that led our national struggle for independence.

Together, these make an exquisite triangle encompassing all our National values, and FRNV draws its inspiration from this ocean of strength.

Our National Values consist of discipline, restraint, and the ideal to stimulate the consciousness of all, to achieve:

- *Eradication of inner constrictions born out of selfishness and greed;*
- *Imbuement of a warm fondness for society and concern for the collective good; and*
- *Building of sufficient inner strength and character, in the individual, family and society as a whole.*

Our Strategy

- II. As the crisis has its roots in the mind and intelligence, aim at stimulating change at a germinal level.
- III. Encourage and assist grassroots level activities for implementation of programmes consistent with our objectives;
- IV. In particular, stimulate youth to play greater role in restoring National Values, through on campus and off campus activities aimed at fostering discipline, patriotism and respect for elders;
- V. Take appropriate action, including legal, to achieve the aims of the organization.

Our Focus Areas

Towards creating a Value-based Society, FRNV focuses on the following areas:

I. Values-Based Education:

The main focus of this project is to implement FRNV's Values-based education methodology across schools in our country. FRNV's mission is to become known as an 'Opinion Leader' in the area of Values-based education in the country.

II. Electoral and Administrative Reforms (including Judicial Reforms):

FRNV will focus on achieving the following:

- Prevention of people with criminal background from contesting elections;
- Prevention of money and muscle power in conduct of elections;
- Legislative backing to implement code of conduct during elections;
- Speedy disposal of poll petitions and criminal cases against poll candidates;
- Ensure accountability of elected representatives to the electorate;
- Improve transparency and effectiveness in public administration;
- Ensure greater governance with less government and;
- Speedy disposal of pending cases in courts.

III. Police Reforms:

FRNV will focus on achieving the following:

- Implementation of recommendations made by the supreme court;
- Prompt registration of First Information reports and Investigation;
- Proper follow up of prosecution cases in courts;
- Making police people friendly and;
- Setting up of effective Police Complaints Authority and prompt deterrent action against offenders.

IV. Sanitation and Hygiene:

FRNV advocates on waste segregation, solid-waste management and educating citizens about civic sense.

V. Corporate Engagements for Ethics & Governance:

At the Foundation for Restoration of National Values, we believe that corporate integrity is important to attain sustainable development. We seek to stimulate the inner consciousness of corporate leaders and strive to maintain a high level of transparency within the organizations.

Our Regional Chapters

FRNV does not restrict itself within the region of Delhi and aims at expanding its motives to all parts of the country. The efficient functioning of the regional chapters will ensure effective implementation of police reforms in the different states as per Supreme Court directives, implementation of value-based education in the different tiers of education across all states of the country and to implement electoral and administrative

reforms across the nation in an attempt to prevent value erosion and eradicate corruption.

Foundation for Restoration of National Values has three Regional Chapters:

1. Kerala Chapter - 1 Trivandrum

Trivandrum chapter is headed by Dr M. Ayyappan. They are doing extensive work on Sanitation/Hygiene and training corporate houses on conducting business with ethics.

2. Kerala Chapter- 2 Kochi

Kochi chapter is headed by Dr Devika Menon under direct guidance of President Dr E Sreedharan. They are doing extensive work on value education for students and disaster management.

3. Karnataka Chapter- Bangalore

Karnataka Chapter is headed by Sri V. Vishwanath. The chapter was launched on August 13, 2016, at Bengaluru. This chapter has been working in the following areas: Values-based Education, Corporate Integrity and Police Reforms.

Organizational Structure

FRNV Activities - 2019-2020

Value-based Education

FRNV believes that instead of making Value Education a separate subject, it would be more useful to integrate the values like fraternity, democracy, social justice, freedom etc., in the design and content of the curriculum.

Subsequently, a MoU was signed in 2016 with Shri Ram Global School to further its goal of spreading and establishing the need for Value inculcation in the students; and a field study was carried out in Shri Ram Global School, Gurugram and Dehradun. Based on the results of this study, a pilot project on Values-based education was implemented with the permission of Govt. of Delhi in some of the schools of Delhi. After one year of implementation, an evaluation study was conducted to study the impact of the intervention. It was found that there is a need for a value education curriculum in the schools.

A survey in Ernakulam District was also conducted and the results revealed that schools run by Bharatiya Vidya Bhawan, Chinmaya Mission, and Christian Institutions; however, no moral education is being imparted in Govt. and aided schools.

President, FRNV approached Govt. of Karnataka for the implementation of Value Education. During this meeting, the State Govt. asked for the VE curriculum. Consequently, it was decided to come up with a common curriculum which can be implemented across the nation.

Accordingly, FRNV setup an expert committee of eminent educationists under the guidance of Smt. Vibha Parthasarathi. The expert committee had series of workshops and decided that we should develop Value Education Teachers' Manuals. It was suggested that teachers' Handbook should be developed which is comprehensive so teachers can implement it without any additional training or resources. The curriculum for primary classes was divided into two parts; one for grade 1-3; and second for grade 4-5. Further, the curriculum for secondary was also divided into two parts, i.e., for grade 6-8 and grade 9-12.

- FRNV has already brought out teachers' manuals for class 1 – 3 and 4 – 5 to guide teachers how ethics, values and principles have to be transferred to the young minds.
- FRNV has completed the Hindi translation and also printing of Teachers' Manuals for class 1-3 and 4-5.
- FRNV is in the process of content editing and format editing of Teachers' Manual for class 6-8.
- In the month of June 2019, FRNV has again submitted its feedback on the draft NEP 2019 and made its recommendation to MHRD to bring an amendment in the Right to Education Act by making Value Education an integral part of the RTE act.

Students Chapters

FRNV has launched its first Students Chapter at School of Engineering at Cochin University of Science & Technology (CUSAT) on 09AUG19. FRNV is now working on creating more awareness to other colleges on this matter and hope to have more institutions join hands with us in future.

After a meeting with Commissioner of Public Instruction Mr. Jagdeesh, IAS in January 2020, we have received a letter from DSERT acknowledging our efforts and including 'Teachers Manual' of 'Value Education' from FRNV for including in the syllabus of School Education on the 'Bag less Day' of Govt. Schools across

Karnataka.

FRNV – 11th Foundation Day Celebration

The Foundation for Restoration of National Values celebrated its 11th Foundation Day on 8th June, 2019 at Delhi Metro Rail Corporation Ltd (DMRC) Auditorium, New Delhi.

The former President of our country, Shri. Pranab Mukherjee. He also released a souvenir on the occasion based on the theme of the 11th Foundation Day, which was “The Values We Stand For”.

Regional Chapters

FRNV believes that any National Movement to be effective, wholesome and beneficial to the citizens of a nation must percolate to the local level. With this in mind, FRNV started its Regional Chapters to take this vision to every doorstep and bring about rapid changes in the value system of the citizens of the country.

Regional Chapters will be established under the umbrella of the **Foundation for Restoration of National Values**.

They will have their own Convener and a task force independently, while remaining their own entity. However, FRNV, the parent organization will have a decisive say in the way these activities are handled, and might want to help with technical support. Members are expected to strictly observe FRNV ethic, values and principles and strive to propagate these values to other members of the society.

FRNV Governing body prepared guidelines for formation of Regional chapters and approved.

FRNV Trivandrum Chapter

The Foundation for Restoration of National Values, Trivandrum Chapter organised “An interactive session with Mr. E. Sreedharan” held on 2nd November 2019 at The Tennis Club, Trivandrum, jointly with the Trivandrum Management Association. The event was well attended and a total of 90 participants including management executives and students enlightened the evening. Eminent personalities working in different sectors like Dr. Sahadullah, CMD, KIMS Healthcare, Dr. Ayyappan, Former CMD, HLL, Rajesh Jha, MD & CEO of Vizhinjam Port, Dr. P. T. Nandakumar, Retd. IPS also participated. FRNV's future activities were discussed and it was decided to form **3 task forces** as under:

1. Solid Waste Management
2. Value Education
3. Road Safety and Maintenance



FRNV Karnataka Chapter

- I. Dr. E. Sreedharan, President FRNV met with following officials of Government of Karnataka on 26th August 2019 to look into the possibilities of including 'Value Based Education' in Government School curriculum for class 1 to 7. Meeting was cordial and Bureaucrats were excited to look at the possibility joining hands with FRNV and making 'Value Based Education' a success.
 - Mr S R Umashankar, IAS, Principal Secretary to Government, Department of Primary and Secondary Education, Government of Karnataka and
 - Dr. Shalini Rajneesh, IAS, Principal Secretary to Government, Planning, Statistics and Programme Monitoring Department.
- II. Dr. E Sreedharan, President FRNV sent a letter in mid-September 2019 – which was handed over to Principal Secretaries to include 'Value Based Education' along with the copy of FRNV booklets of 'Value Based Education'.
- III. Dr. E. Sreedharan met Karnataka Chapter Members and Friends in the office of convener Mr. Vishwanath on 25th October 2019 and had a fruitful discussion on way forward for FRNV Karnataka Chapter.
- IV. Mr. V. Vishwanath, Convenor Karnataka Chapter met Mr. Jagadeesh, IAS, Commissioner of Public Instruction in January 2020 as a follow up for including the booklet of 'Value Based Education' of FRNV in government Schools, Bureaucrats took action and we received a letter from DSERT acknowledging our efforts and including 'Teachers Manual of Value Education' from FRNV for including in the syllabus of School Education on the 'Bag less Day' of Govt. Schools across Karnataka.

The 'Teachers' Manuals for Value Based Education' are being translated to Kannada for implementation in all schools in Karnataka.



FRNV Kochi Chapter

The details of the Kochi Chapter activities for the year 2019-20 is listed below in brief.

1. New Memberships: We have received 2 Corporate, 1 Life & 2 Annual memberships this year.

2. A programme for College Principals on campus Discipline on 28 Sep 2019:

A fruitful activity of FRNV, Kochi Chapter was a programme for College Principals in Kerala which was widely attended by them? The topic of discussion was Restoration of Ethics, values & discipline in college campuses and Honorable Retd. Justice Kemal Pasha was the keynote speaker. He was of the view that students should not become tools of the political parties and they should be discouraged from bringing weapons to college. The programme was presided over by Dr. E Sreedharan and he emphasized the need for including social services and environment conservation as part of their extracurricular activities.



Formation of Students Chapters

FRNV proposes to engage with Universities and Colleges around the country to create student chapters, with the

active involvement of the College/University Administration and Faculties, for the inculcation of National Values and the skills enumerated above.

FRNV Governing body prepared guidelines for formation of Students chapters and approved.

- **Student Chapter in School of Engineering in CUSAT**

Topic: Restoration of Ethics, values & discipline in college campuses, with Keynote speaker: Retd. Justice B. Kemal Pasha.

The students chapter of Foundation for Restoration of National Values (FRNV) of which Dr. E Sreedharan, Principal Advisor, DMRC, is the founder president was formally inaugurated on 9th August, 2019 in School of Engineering, Cochin University of Science & Technology, Kochi, in the august presence of Prof (Dr.) George Mathew, Principal School of Engineering & Prof. M. R. Radhakrishnan Panicker, Former Principal. The prime aim of the students' chapter is to install the eternal values of nationhood among the young and make them responsible citizens of the country. Twenty-eight students from seven engineering disciplines volunteered to form the core group and one professor has been designated as the Patron of the Chapter. FRNV students will also undertake community services within the campus.



- **Student Chapter in Amity University**

As part of our endeavor to bring in youth into the FRNV fold, while simultaneously instilling in them the essential Values and capabilities needed to make them ethical and upright citizens of India, a team of FRNV Governing body members comprising Shri Satish Kumar (Governing Body Member), Shri Gopal Ganesh (Vice-President) and Shri Bharat (General Secretary), visited the Amity University Haryana (AUH) on May 15, 2019, where the Vice-Chancellor, Professor P B Sharma and his faculty colleagues interacted with us.

The main objective of this discussion was to establish student's chapter in the University to nurture the national values amongst students and faculty. Prof Sharma expressed his happiness in his association with FRNV and the readiness to explore the ways of working together of AUH and FRNV for the noble cause of restoration of National Values. Vice-Chancellor agreed to consider to establish a students' chapter of FRNV in AUH, to teach students learning by doing, and the importance of team work, compassion and communicating truthfully.
